## On the LAO Front by Curt

Well there have now been two lawsuits filed against the Eldorado National Forest Motorized Travel Management Plan. Earlier this year a mining group, Public Lands for the People (PLP), filed a suit that included arguments on how the final decision negatively impacts recreational OHV use. Of course recreational OHV access is not the primary focus of their complaint, but at least they are trying to get more motorized access for all.

The second suit, filed this past month, is the always expected one coming from the anti-access groups. The Center for Sierra Nevada Conservation (Karen Schambach), Center for Biological Diversity, and Forest Issues Group are trying to get the current plan thrown out so the forest service can come up with one that is much more restrictive. Obviously the closing of over half the roads and trails that exist in the ENF to motorized access wasn't enough, and neither is completely closing the forest to OHV access for at least 1/4 of the year.

Of immediate concern to the Polka Dots is how these lawsuits might impact our attempts to get a 10 year permit for running our enduros. We are on for this year's 49er with a single event one year permit, but the future may now be in even greater doubt with these legal issues looming.
